机动车辆及轮胎产品的海湾七国准入要求

GCC Access Requirement for Motor Vehicles and Tyre Products

GSO即GCC的标准组织，GCC是海湾阿拉伯国家合作委员会（Gulf Cooperation Council）的缩写。其成员国包括沙特阿拉伯、科威特、阿拉伯联合酋长国、卡塔尔、阿曼苏丹王国、巴林王国以及也门共和国等七国。

自2005年1月1日起，GSO依照相关海湾标准对机动车辆及轮胎产品进行检验并签发GCC一致性认可证书，被批准的GCC证书将在所有GCC成员国国内有效。GCC认证是一种强制性认证，机动车辆和轮胎等产品必须取得GCC证书后，方可进入海湾国家市场。

2017年3月起，GSO接受德国莱茵TÜV出具的ISO 17020认可范围的测试报告，为客户产品快速进入海湾市场提供保障。

GSO is the standard organisation of the Gulf Cooperation Council, or GCC. Its seven member countries are the Kingdom of Saudi Arabia, the State of Kuwait, the United Arab Emirates, the State of Qatar, the Sultanate of Oman, the Kingdom of Bahrain and the Republic of Yemen.

GSO has conducted tests and issued GCC Conformity Certificate in accordance with the relevant Gulf Standards (GS) since 1 January 2005, and the approved GCC Conformity Certificates are acceptable in all GCC countries. GCC certification is a kind of compulsory certification, which means all motor vehicles, type products and other products must obtain GCC certificates before they enter the markets of GCC member countries.

GSO has adopted test reports issued by TÜV Rheinland within the scope of ISO 17020, since March 2017. It guarantees our customer's products access to GCC member countries rapidly.
