In order to protect the consumers in Uganda from sub-standard products and to assure safe and quality approved products enter the Ugandan market, the Uganda National Bureau of Standards has implemented under UNBS Act of 1983 mandatory requirements for product imports under the Pre-Export Verification of Conformity to Standards Programme (PVOC).

The PVOC program requires that regulated product imports are verified for compliance in the country of export and before entering the Ugandan market.

Shipments of a value below USD 2,000 are not subject to PVOC.

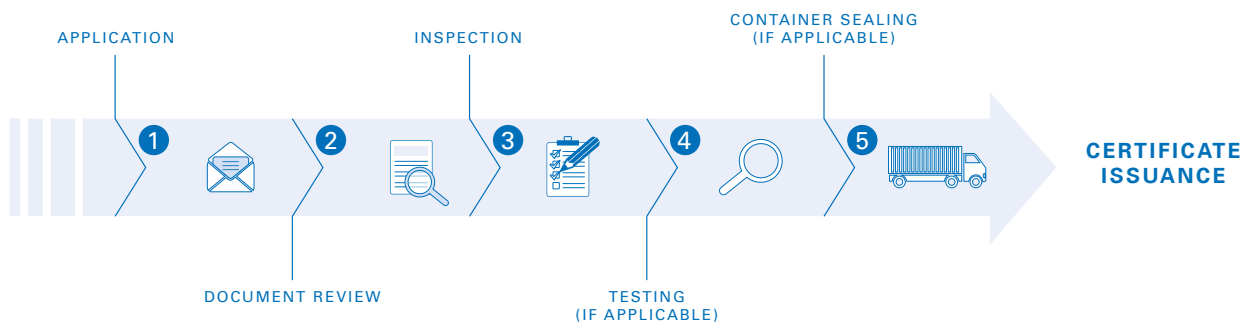
1. Accepted plug type: G
2. Markings and labeling on products have to be English

3. Voltage 240 V
4. Frequency 50 Hz
5. Threshold of shelf life for non-food items: 50% from the expiration date
6. Threshold of shelf life for food items: 75% from the expiration date
