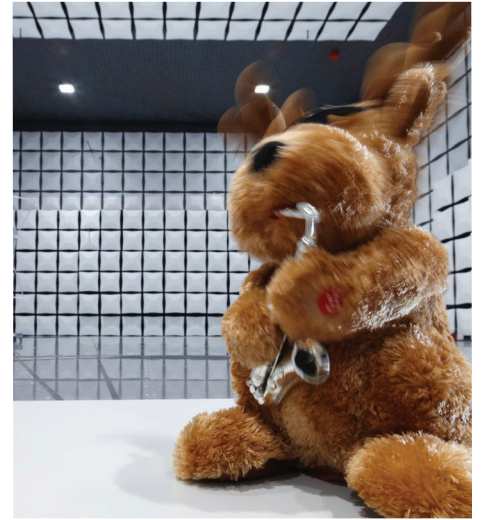

- Your suppliers and consumers will be able to view information related to the certificate through the Certipedia website (www.certipedia.com)



玩具认证标识的特性

- 与带有CE标识的大多数产品有着显著不同，被授予此标识的产品需同时符合玩具指令2009/48/EC和德国其它相关法律法案，如设备和产品安全法（ProdSG）和德国商品条例（BedGgstV）以及其它法律法规
- 电池和电动操作产品（如遥控车和火车模型）需满足EN 62115和其他关于电磁兼容性（EMC）的EEC指令要求
- 德国莱茵TÜV的玩具产品目录补充了EN 71的要求，同时我们还会根据欧盟玩具安全指令2009/48/EC进行与特定产品组相关的附加测试
- 玩具验证标识根据产品测试结果进行测评
- 玩具验证标识有效期上限为5年。工厂检查会于合约期内进行，以确保玩具产品安全和质量
- 当同系列产品的所有材料经过测试后，我们可为其颁发组合产品证书
- 使用QR码，可在几秒钟内浏览相关的检测范围



Features of the Toy Proof Mark

- Products awarded this unique mark benefit from comparison to the vast number of toys that bear the CE mark alone. Products bearing this mark meet the requirements of Toy Directive 2009/48/EC and other applicable laws and acts in Germany, such as the Product Safety Act – ProdSG and the German Commodities Ordinance, BedGgstV
- For battery and electrically operated products (e.g. remote-controlled cars and model railways), the requirements of EN 62115 and the other EEC Directive on Electromagnetic Compatibility (EMC) are applicable
- The TÜV Rheinland Criteria Catalogue for Toys supplements the requirements of EN 71, and additional tests that relate specifically to the product group are also carried out, pursuant to the intention of the EU Toy Safety Directive 2009/48/EC
- The Toy Proof Mark is awarded based on product test results
- The mark is valid for maximum 5 years. Factory inspection takes place during the contract term to ensure safety and quality within the life-time of the toys
- A group product certificate can be issued when all material within the product series has been tested
- With the QR code, the associated testing scopes are accessible in a matter of seconds
