Defining environmental, social, and governance principles and criteria, the standard provides guidelines to help the aluminum industry assure industrial users and concerned consumers of its commitment to the responsible sourcing of aluminum, as well as sustainability in manufacturing and fabrication.

ASI PERFORMANCE STANDARD IN THE VALUE CHAIN

Areas throughout the entire aluminum supply chain including greenhouse gas emissions, waste management and material control, as well as environmental biodiversity and human rights issues are addressed in the standard. Our accredited auditors are well-versed in guidance documentation for the ASI Performance Standard, providing you the expertise you need to determine potential risk, explain special terms or processes, reference other international standards, guidelines or toolkits, and present you with reliable good practice examples according to the size and maturity of your facility and business.

OUR RECOGNIZED ASI PERFORMANCE STANDARD AUDITING SERVICES

Developed for global implementation throughout the aluminum value chain, the ASI Performance Standard applies to all phases of aluminum production and transformation, as well as material stewardship criteria pertinent to downstream users. Our accredited auditors follow a 5-step process to help you achieve and maintain voluntary ASI Certification. Both certification and the prestigious ASI quality mark are issued by the Aluminium Stewardship Initiative after the completion of a successful audit.

STEPS TO ASI CERTIFICATION

1. Self Assessment

Preparation phase in advance of the certification audit. Following initial registration, ASI members examine the current level of their individual conformance to the performance standard in accordance with the defined scope of certification.

2. Certification Audit

Risk-based conformity assessment carried out by our ASI accredited auditors, during which we verify that existing systems conform to the ASI Performance Standard.

3. Audit Report

Audit results are reported to ASI and the member. Appropriate corrective action plans are submitted in the report as needed.

4. Certification

After receiving a report and certification recommendation from our accredited auditor, ASI will determine the audit clear and complete and issue a 3-year certificate. The ASI website will be updated to reflect the certification.

5. Periodic Reviews

A surveillance audit is performed within 12-18 months. An audit to assess risk and verify continued compliance is conducted at the end of the 3-year validity period to renew certification.



Current ASI members are required to have at least one factory certified according to the ASI Performance Standard by established deadlines.
