As an authorized international surveyor, TÜV Rheinland can provide inspection, testing, analysis, and conformity assessment services, concluding with issuing Cols for regulated products exported to Sudan.

According to the Sudanese regulations, products intended for import must undergo a conformity assessment process in their country of origin or country of exports, and a Certificate of Inspection (COI) is issued as proof that the products comply with relevant standards and regulations.

PROCESS OF OBTAINING THE CERTIFICATE OF INSPECTION (COI)



IN ORDER TO INITIATE THE PROCESS, THE FOLLOWING DOCUMENTS ARE SUBMITTED BY THE APPLICANT:

- TÜV Rheinland application form signed and duly filled
- Final invoice and packing list
- Certificate of Origin (COO)
- Registration or Trade license
- Test Report from ISO 17025 accredited laboratory
